The purpose of this correspondence is to inform you of a technical amendment to the SFY 2008 – 2011 Transportation Improvement Program (TIP), dated May 11, 2007, involving the following project:

- CUY STEARNS RD (PEDD): PID No. 80729 – The construction phase and right-way phases of this project are currently listed on page 49 of the TIP. However, the preliminary engineering – detailed design (PEDD) phase is not included in the TIP. The PEDD phase is \$600,000. ODOT District 12 has requested a technical amendment to include the PEDD phase of the project in SFY 2010.
