BACKGROUND

Purpose

The Economic Development Subcommittee shall provide advice and policy recommendations to the Policy Committee to support economic growth and enhance quality of life.

Goals

- Operate as the CEDS Strategy Committee, as required by U.S. EDA
- Inform NOACA of relevant economic development matters
- Foster sustainable and equitable economic growth
- Provide input and recommendations in NOACA project planning and prioritization
- Be a forum for regional collaboration to support regional economic growth

BACKGROUND

CY 2025 Subcommittee Focus Area accomplishments

- **Implement and refine adopted performance measures**
 - Continued refinement of baseline performance measures adopted in December 2024
- **Promote community collaboration through regional projects**
 - Presentation of the Aerozone Transportation and Economic Development Initiative (TEDI)
 - Stakeholder jurisdictions, and Cleveland Hopkins Int'l Airport, and NASA Glenn Research Center (50 square miles)
 - **TEDI Objective:** Stimulate regional economic growth through aerospace, advanced manufacturing, and logistics
- **Educate communities on the CEDS and its benefits to their areas**
 - Staff continues to review the CEDS and educate stakeholders

BACKGROUND

CY 2025 Subcommittee Focus Area accomplishments

- **Create a centralized repository for all information**
 - NOACA will partner with CSU to provide data intended to:
 - Inform stakeholders (Proof beyond intuition of a project's need/funding)
 - Guide local policy (Promote reactive policy for measured economic growth)
 - Strengthen the understanding of economic conditions
 - Guide strategic decision-making across CEDS priority areas
- **EDA approval of the economic development district designation**
 - Submitted additional requested information to EDA
